The cover

Particle transport through mucus depends on size and surface chemistry. Left to right: (1) small particles that do not bind mucus penetrate mucus barriers easily; (2) particles that bind mucus are trapped within it; (3) particles that would otherwise be trapped may be coated to prevent binding and penetrate mucus barriers; and (4) particles larger than the mucus mesh size cannot penetrate mucus regardless of surface chemistry.
